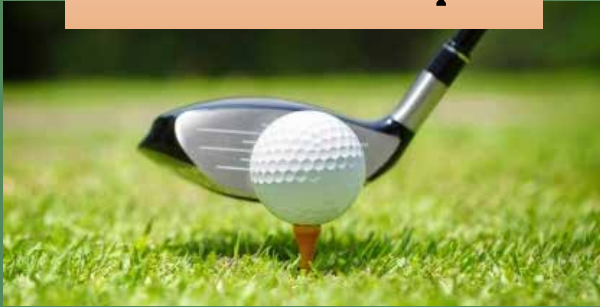

## HOTEL INFORMATION

Loews Royal Pacific Hotel is located at Universal Park. This hotel recreates the glamour, charm and romance of the 1930's when island hopping the South Pacific was a once-in-a-lifetime adventure for the privileged few. At this tropical paradise, island breezes dance through the palms. A serene orchid court where flowers are always in bloom soothes your spirit. From the bamboo forest entrance and swaying palm trees to the enchanting outdoor gardens and tropic lotus lagoon, you will find unsurpassed recreation.

TIA has contracted for a block of sleeping rooms at the hotel at a very special rate of \$242 single or double occupancy plus 12.5% sales tax. Links to hotel reservations are provided in the conference registration confirmation email. *Conference registration must be received before making hotel reservations.*

At this time, the room block rates are available until Friday, March 13, 2015. After that, the room block will be released to general sales. You may be able to secure a room after this date, however, the cost may be higher.

TIA must commit and guarantee a block of rooms at the hotel in exchange for meeting space. Members who choose to stay in a hotel other than the Loews Royal Pacific or book via the Internet outside our block of rooms will cause TIA to suffer a monetary penalty, and will therefore have \$100 added to their registration fee for the meeting.

The Loews Royal Pacific Resort has self and valet parking. Rates are \$15 per day/per car for self parking and \$22 per day/per car for Valet.

## AIR

Orlando is serviced by a large number of airlines. Because of widely available discounted Internet airline rates, TIA is not offering special airfare information this year.

## GROUND

The Loews Royal Pacific Hotel is located 25 minutes from the Orlando International Airport. Taxi fares usually run \$45 - \$50. The hotel offers return sedans to the airport at a rate of \$55.
